Hello City of Monrovia,

I am writing this letter as a concerned parent of a student who goes to the daycare Happy Lil' Campers, located next to the home at 236 E. Wyland Way.

The occupants have shown illegal and inappropriate behavior over the last 3 years that I have been driving up to the home twice a day Monday-Thursday at 9am and 5pm. They have multiple people coming throughout the day and going bringing bicycles that are obviously not theirs. Riding over with 1-2 extra with them, some children's bikes, and sitting in the driveway taking them apart. When the garage door is open there has been floor to ceiling stacked with bicycle parts. If the side gate is open you can see stacks and stacks of metal parts all over. In the evenings, I have seen random cars and frequent cars coming and staying for short periods to exchange handshakes with whoever is in the front yard and receiving something in return. I cannot confirm what they are handing back and forth but it is obvious it is drug related. The owners of the home next door have called the police multiple times and nothing is being done about these folks. There was an instance one day at pickup where I was loading my toddler into the car and one of the men who live there ran outside belligerently and shirtless screaming at a random man on a bike, bringing another bike over to his brother, and chased him down the street. After this the Temple City Sheriff's office started doing rounds by the house but that lasted for a week or so. Something needs to be done about this, the Sheriff's department is aware of this house and is doing nothing to help the families on the street.

I am happy to provide more information to whoever I need to speak with to help move things along. We love this street and our daycare so much. I grew up in Monrovia and it has a special place in my heart and now my sons.

Hi,

I have been a resident in Monrovia since 2019. I chose Monrovia as the city I wanted to live in because of its beautiful community. After buying our house and moving in it was peaceful and very neighborhood friendly. The neighbor to my right Rick Booth (Passed Away) Cindy Booth Her youngest son Nathen suffers from (Advanced delusionary schizophrenia with involuntary narcissistic rage) (lives next door to the right of my house. Kyle Booth (Bipolar Disorder) middle child got out of Prison 2 time convicted felon after serving a 5 year sentence. It was around the spring of 2021. He was a decently reformed person when I met him. After he did his Parole for 1 year. He got back into Drugs, (Meth, Crack Cocaine) Our neighborhood has never been the same. He Deals, Sells and Consumes drugs out of his Mother's house (we can smell the drugs from our home). There is a surplus in Junky's, Drug addicts and all sorts of people in our neighborhood now. Kyle Booth is very Violent does not respect any hours of the night as he is in his backyard drilling & grinding and making all sorts of noise at 3:00am. He has a young girl staying with him whom he drugs and abuses. Her parents came to their house to try and see her. He chased them off his Mom's property while swinging a golf Club at their heads, hit my fence and put a serious dent in it. It has been said that he hides a firearm in his Mom's backyard in some old used tires. He has also had many altercations with his younger brother Nathen. He was chasing his younger brother completely naked in broad daylight and my son (10 years) witnessed a grown man showing his genitals to everyone with no shame at all. He has threatened my family and other neighbors' lives stating he can make us disappear if he wanted when we threaten to call the Sheriff's on him. His Mother Cindy Booth has attempted to keep him from acting up, but she is also afraid of him as we've been told he had fractured his mothers face by head bunting her when she tried correcting his behaviour before we moved into the neighborhood. The neighbors and ourselves have countless calls to the sheriff's dept on record, we have a case open with crime stoppers ([P3TIPS.COM](https://www.p3tips.com)) He has Threatened my wife personally and does not care if he hits a woman like they are a man. Everyone in our neighborhood Cul De Sac are tired of this individual and the chaos he creates daily. It roughly takes the Sheriff's 15 minutes to get to our address if a 911 call is made. We need to put an end to this before someone gets seriously hurt or loses their life. I come to you as a very concerned Father, Husband resident of Monrovia. Something has to be done enough is enough.
