

ORDINANCE NO. 2025-05

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MONROVIA, CALIFORNIA, AMENDING CHAPTER 8.04 OF TITLE 8 OF THE MONROVIA MUNICIPAL CODE AND ADOPTING BY REFERENCE AMENDED DIVISION 1 OF TITLE 8, AND TITLE 11 OF THE COUNTY OF LOS ANGELES CODE AS THE HEALTH CODE OF THE CITY OF MONROVIA

THE CITY COUNCIL OF THE CITY OF MONROVIA, CALIFORNIA does ordain as follows:

SECTION 1. Section 8.04.010 and Section 8.04.020 of Chapter 8.04 (Health Code) of Title 18 (Health and Safety) of the Monrovia Municipal Code are hereby repealed and replaced with the following:

“8.04.010 ADOPTION OF LOS ANGELES COUNTY HEALTH CODE.

The City adopts by reference the current version of Division 1 of Title 8 of the Los Angeles County Code (Public Health Licensing Regulations) and Title 11 of the Los Angeles County Code (Health Code), as either Code may be amended from time to time by the Los Angeles County Board of Supervisors, which shall henceforth collectively be known as the 'Health Code of the City of Monrovia.'"

8.04.020 COPIES FILED.

The City Clerk shall maintain on file at all times current copies of Division 1 of Title 8, and Title 11, of the Los Angeles County Code as most recently adopted in Section 8.04.010, for use and examination by the public."

SECTION 2. Section 8.04.050 of the Monrovia Municipal Code is hereby added, to read as follows:

“8.04.050 PERFORMANCE OF PUBLIC HEALTH SERVICES.

The Los Angeles County Department of Public Health shall perform public health services for the City in accordance with provisions of the Los Angeles County Code adopted herein by reference and the City's latest Public Health Services Agreement with the County."

SECTION 3. The amendments to Chapter 8.04 of Title 8 of the Monrovia Municipal Code shall not affect or excuse any violation of said chapter occurring prior to the effective date of this ordinance.


SECTION 4. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the decision of any court

of competent jurisdiction, such decision shall not affect the validity of the remainder of this ordinance. The City Council hereby declares that it would have adopted this ordinance, and each and every section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 5. The City Clerk shall certify to the passage of this Ordinance and shall cause the same or a summary to be published pursuant to state law, and said Ordinance shall become effective 30 days after its passage.


